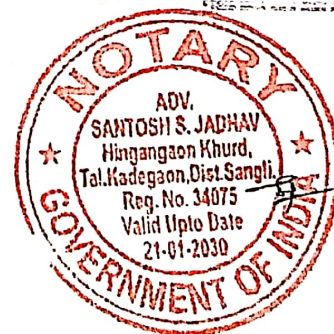

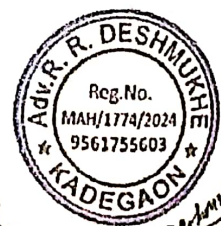

I, Educational Officer (Primary) hereby giving temporary recognition Saraswati Global School Kadepur, Tal. Kadegaon for Std. 1st to 8<sup>th</sup> from 01/04/2022 to 31/03/2025 I. e. for 3 yrs.

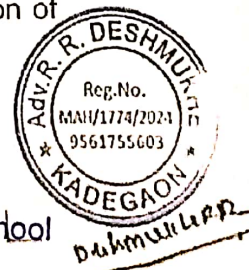
- Above recognition is subject to fulfillment of below mentioned conditions:

- 1) Period of recognition shall not be extended and there shall not be compulsion to give recognition of affiliation after Std. 8<sup>th</sup> in any situation.
- 2) The School shall obey the provisions given u/Rights of Children's to free and compulsory education Act, 2009 and Rights of Children's to free and compulsory education Act, 2011
- 3) The School shall give admission to 25% of total strength of students for deprived and infirm children's staying nearby to School in Std. 1st and school shall give them free and compulsory education till they complete their primary education and also the said ratio shall be applied to Pre Primary standards.
- 4) As per the provisions of sec. 12(2) of Act, for the Children's mentioned in Para 3, the School shall get compensated and to receive the said compensation school shall be given a separate bank account.
- 5) Institute/School shall not take any capitation fee and shall not constrain child or his or her father mother or parents to any scrutiny.
- 6) no child shall be denied to get admitted in the school for the reason of non availability of his age proof or for the reason of religion, caste or race, place of birth or any of them.
- 7) 1] Child shall not be kept in the same standard again or shall not be removed from school till he completes his primary education.  
2] No child shall be subject to physical or mental cruelty.  
3) It shall not be needed to any child to get passed exam conducted by any board until he completes primary education.  
4] Every child who has completed his primary education shall be warded with a Certificate provided u/sec. 23.  
5) Handicapped/Special Child students shall get admitted as per provision of act.

7) He/She shall fulfill the responsibilities provided u/sec. 24(1) of Act which are supposed to be fulfilled by Teachers.



18) Renewal of society registration is to be ensured.

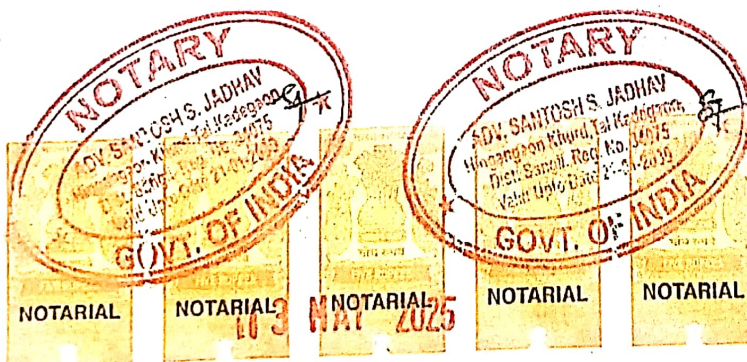
